TERMS & CONDITIONS of Enrolment at SMArt Centre

1. RIGHT OF ADMISSION:

SMART CENTRE reserves the right of admission to our premises and the right to tuition.

2. ENROLLMENT:

Annual Enrolment is required. Returning students DO NOT pay the new registration fee if returning before 1 February in the new year.

3. REGISTRATION FEE:

A Registration Fee for NEW students will be charged irrespective of date of enrolment.

4. FEES:

Tuition at Smart Centre is provided on a MONTH-TO-MONTH or TERMLY basis.

Tuition will only be provided if accounts are up to date and paid for in full, as per the 2025 Fee Structure.

Monthly fees are calculated according to the number of lessons offered by SMArt Centre - per subject in any given month – (As per Smart Centre 2025 Calendar).

This arrangement Applies from the date of enrolment to the 30th of November 2025. (Gr. 5 to Gr. 11)

Matrics will be invoiced in full only until 31 October 2025. Lessons attended by Matrics in November of 2025 will be charged for on a pay-as-you-go basis.

EXTREMELY IMPORTANT!! - SMART CENTRE FOLLOWS ITS OWN CALENDAR - WHICH IS NOT ALLIGNED WITH ANY PARTICULAR SCHOOL CALENDAR.

NO REFUNDS or CREDITS will be passed for any lessons missed by a student for ANY reason. A student may attend a group lesson or alternative group lesson (if available) in lieu of a missed PVT/SEMI-PVT lesson. Fees paid cannot be transferred or exchanged for PVT lessons. Lessons missed through no fault of SMArt Centre, will be forfeited by the student. Should a lesson be cancelled by SMArt Centre for any reason, the session will be re-scheduled failing which, a credit will be passed on your account.

You will not be invoiced for any lessons during Smart Centre holidays or on public holidays - except when special arrangements have been made for lessons on such days.

IT'S IMPORTANT TO NOTE THAT MONTHLY FEES WILL VARY DEPENDING ON HOW MANY TEACHING DAYS THERE ARE IN ANY PARTICULAR MONTH.

5. **PENALTIES:**

All Fees are strictly payable up-front. A R200.00 admin levy or 10% interest (whichever is the greater amount) will be charged to accounts not settled by the 5th of any given month – unless a special agreement has been reached between Smart Centre and the person responsible for the account. Please don't ignore Statements and messages regarding outstanding fees. We are prepared to talk about terms should you encounter difficulties during the year. Nothing sours relationships more than indifference or stonewalling, so, please communicate with us should you experience difficulties in meeting your financial obligations to us.

6. **NOTICE PERIOD:**

In good faith, we ask that you give us WRITTEN NOTICE (One Calendar Month) when wishing to terminate tuition at SMArt Centre.

7. **ABSENCE WHILE IN CONTRACT:**

No special concessions regarding monthly fees are given for absences due to holidays, travel, religious observances or for medical reasons. In cases where a student is absent due to religious or medical reasons, the missed group lessons can be caught up on alternate days (if available) in accordance with the regular timetable. No special catch-up lessons will be granted outside of the timetabled slots. Special PVT lessons may be booked and paid for if required. These are subject to the availability of slots. In short ... if you wish to keep your slot, you will be required to pay for it.

8. **LAST MINUTE CANCELLATIONS:**

In principle, we regard habitual last-minute cancellations (without reasonable excuse) as being very rude. Smart Centre will not tolerate any flagrant disregard for its tutors - all of whom are seasoned professional educators. We require all parties to treat them, their time, & appointments with you, with great respect.

9. **MATRIC EXAM PREPARATION WORKSHOPS:**

Exam Preparation Workshops are NOT included in the regular pricing structure and will be billed for separately. Prices for these sessions may vary and will be indicated on the relevant programmes when published. Advanced Bookings are required for all workshops and no refunds will be given for last minute cancellations or no-shows.

10. **PRIVATE & SPECIAL GROUP LESSONS:**

PVT or SEMI-PVT Lessons can be arranged by mutual agreement between SMArt Centre and the Student/s involved and will be administered according to the *Revised PVT Lessons Policy document of 2025.*

11. **COMMUNICATION:**

Telephonic communication is difficult for us, since we are always teaching. Communication should therefore be conducted via WhatsApp or Email as far as possible.

12. **NOISE, DRIVING & PARKING:**

Smart Centre and Neptune Street are **Quiet Zones** and every effort should be made to be as unintrusive and inconspicuous to our neighbours as possible. **Please DO NOT idle your vehicles while you wait.** The noise is very distracting to all. Kindly park & drive in a courteous and considerate fashion in and around Smart Centre at all times.
