## **TERMS & CONDITIONS of Enrolment at SMART Centre**

**1. RIGHT OF ADMISSION:**

SMART CENTRE reserves the right of admission to our premises and the right to tuition.

**2. ENROLLMENT:**

Annual Enrolment is required. Returning students DO NOT pay the new registration fee.

**3. REGISTRATION FEE:**

A R350.00 Registration Fee for new students will be charged irrespective of date of enrolment.

4. FEES:

**OPTION 1 – P.A.Y.G (Please note that Registration is a requirement – even for OPTION 1)**

If you choose PAYMENT OPTION 1, payment for a lesson should be made via EFT or at reception **before attending** the lesson. Admission to lessons will be subject to the availability of space, slots & tutors. Students on OPTION 2 receive priority when space is limited.

**OPTION 2 – MONTHLY PAYMENT (CONTRACT)**

Tuition will only be provided if accounts are up to date and paid in full, as per the 2021 Fee Structure.

Monthly fees are calculated according to the number of lessons offered by SMARt Centre - per subject in that month – **(As per Smart Centre 2021 Calendar)**. **This arrangement Applies from the date of enrolment to the 26th of November 2021. Matrics are invoiced in full only till 31 October 2021.** Lessons attended by Matrics in November are charged on a pay-as-you-go basis.

NO REFUNDS or CREDITS will be passed for any lessons missed by a student for any reason. A student may attend a group lesson or alternative group lesson in lieu of a missed lesson. Fees paid cannot be transferred or exchanged for PVT lessons. Lessons missed through no fault of SMARt Centre, **will be forfeited by the student.**

Should a lesson be cancelled by SMARt Centre for any reason, the session will be re-scheduled or a credit will be passed on your account.

You **will not** be invoiced for any lessons during Smart Centre holidays or on public holidays except when special arrangements have been made for lessons on such days.

**IT'S IMPORTANT TO NOTE THAT MONTHLY FEES WILL VARY DEPENDING ON HOW MANY TEACHING DAYS THERE ARE IN ANY PARTICULAR MONTH.**

5. PENALTIES:

All Fees are strictly payable **up front**. A R150.00 admin levy or 10% interest (whichever is the greater amount) will be charged to accounts not settled by the **5<sup>th</sup> of any given month** – unless a special agreement has been reached between Smart Centre and the person responsible for the account. Please don't attempt to ignore Statements and messages regarding outstanding fees. We are prepared to talk about terms should you encounter difficulties during the year. Nothing sours relationships more than indifference or a lack of communication.

6. NOTICE PERIOD:

**One full calendar month's WRITTEN NOTICE is required when wishing to terminate this contract (OPTION 2 ONLY) with SMARt Centre OR if you wish to switch between payment options at any time during the course of the year.**

**Please note that only ONE payment option change will be allowed within the year to prevent the manipulation of the system.**

7. **ABSENCE WHILE IN CONTRACT:**

**No special concessions regarding monthly fees are given (Option 2) for absences due to religious or medical reasons). In cases where a student is absent due to religious or medical reasons, the missed lessons can be caught up on alternate days (if available) in accordance with the regular timetable. No special catch-up lessons will be granted outside of the timetabled slots. Special PVT lessons may be booked and paid for if required. These are subject to the availability of slots.**

8. **EXAM PREPARATION WORKSHOPS (Gr. 11 & 12):**

**Exam Preparation Workshops are NOT included in the regular pricing structure and will be billed for separately. Prices for these sessions may vary and will be indicated on the relevant programmes when published. Advanced Bookings are required for all workshops and no refunds will be given for last minute cancellations or no-shows.**

9. **PRIVATE & SPECIAL GROUP LESSONS:**

**PVT or SEMI-PVT Lessons can be arranged by mutual agreement between SMART Centre and the Student and will be administered according to the PVT Lesson Policy document.**

10. **INDEMNITY:**

**SMART Centre, its owner, consultants and staff are hereby indemnified from any theft, loss or injury incurred on the premises.**
